Freezes assessed value, NOT the tax bill. Must be 65 years old and household income must be under \$65,000 per year.

Senior Homestead Exemption

\$5,000 reduction in value before bill is calculated. Must be 65.

Home Improvement Exemption

Reduction of assessed value equal to the amount of increase caused by new improvement to existing residential property. 4 year exemption - owner occupied required.

Exemption for Veterans with Disabilities

Requires disability statement from VA. Lowers value of property based on % disabled.

Returning Veterans' Homestead Exemption

\$5,000 reduction in value for the year the Veteran returns from active duty in armed conflict, and one year following.

Disabled Persons' Homestead Exemption

\$2,000 reduction in value before the bill is calculated. Must be receiving social security disability payments, have a Class 2 ID card from Secretary of State, or Physician's Statement.
