Past due property taxes

If you have sold this property you should mail this bill to the new owner. If the property tax remains unpaid, you (as the owner of record in the year the tax bill is for) will be notified and published as delinquent. Contact the Assessments Office to verify that the records have been changed for the future years.

Please note that the Treasurer is not responsible for payment on wrong bill or taxpayers not receiving tax bill.

Possible Exemptions - The following exemptions are available to all Illinois Taxpayers for their primary residence:**Owner Occupied Exemption**

\$6,000 reduction in value before bill is calculated.

Senior Citizen Assessment Freeze

Freezes assessed value, NOT the tax bill. Must be 65 years
old and household income must be under \$65,000 per year.

Senior Homestead Exemption

\$5,000 reduction in value before bill is calculated. Must be 65.

Home Improvement Exemption

Reduction of assessed value equal to the amount of
increase caused by new improvement to existing
residential property. 4 year exemption - owner
occupied required.

Exemption for Veterans with Disabilities

Requires disability statement from VA. Lowers value
of property based on % disabled.

Returning Veterans' Homestead Exemption

\$5,000 reduction in value for the year the Veteran
returns from active duty in armed conflict, and one
year following.

Disabled Persons' Homestead Exemption

\$2,000 reduction in value before the bill is calculated.
Must be receiving social security disability payments,
have a Class 2 ID card from Secretary of State, or
Physician's Statement.
